## BOARD ELECTIONS

Three seats on the GreyStone Power Board of Directors are up for election in 2024. The GreyStone Power Nominating Committee has met and chosen Genevieve Cole and Gary Gulleddge in District 1, Paulding and Bartow counties; Neal Dettmering in District 4, Douglas and Carroll counties; and Jim Johns in District 8, Douglas County, as their nominees for the Board of Directors. The winners will be announced in October following the co-op's Annual Meeting.

Eligible members may become a candidate by being selected by the GreyStone Nominating Committee or by nomination by petition of members.

The deadline has passed to be nominated by the Nominating Committee, but eligible members may still run by petition. For those seeking to be nominated by petition, 50 or more signatures from GreyStone members of record (the name must appear on the electric bill) and a Candidate Affidavit must be submitted by Thursday, July 4. 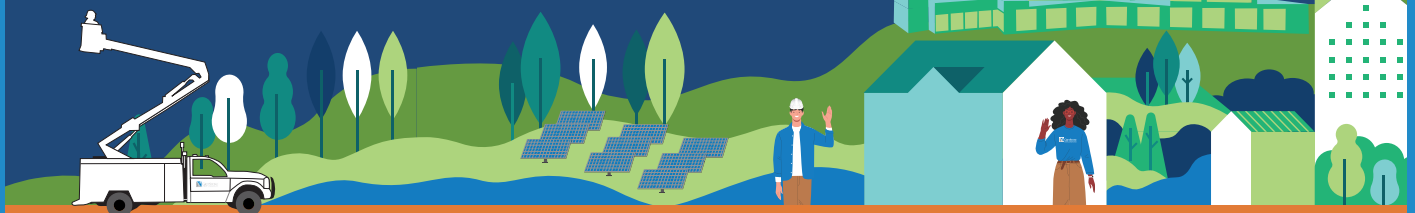
All nominees must live within the geographic boundary of the district they seek to represent, are subject to a criminal and financial background check and must meet all other conditions of eligibility set forth in the Bylaws.

Candidates wanting their name and biographical information included in the Annual Meeting ballot edition of *Georgia Magazine* must submit information in the format and manner required by the Credentials and Election Committee by Tuesday, July 9. 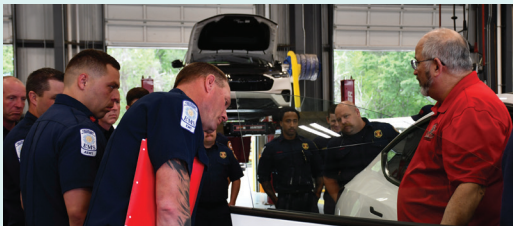
